3390443 NOTICE OF PUBLIC HEARING ON PROPOSED ACTION BY METROPOLITAN SEWER SUBDISTRICT TO IMPOSE SANITARY SEWER SERVICE CHARGES TO CONNECTED CUSTOMERS On February 25, 2019 at 1:30 p.m., the Metropolitan Sewer Subdistrict d/b/a MetroConnects ("Metropolitan"), a special purpose district providing sanitary sewer collection services to approximately 44,000 customers in Greenville County, South Carolina and approximately 300 customers in Anderson County, South Carolina will hold a public hearing at 120 Augusta Arbor Way, Greenville, South Carolina. The purpose of the public hearing is to receive comments from its customers and/or the public on a new schedule of sanitary sewer collection service charges, based on water usage, to be imposed on customers receiving sanitary sewer collection service from Metropolitan. The proposed sanitary sewer service charges would replace the current annual tax millage and

sewer service fees charged and collected by Metropolitan. The Commissioners and staff members will be available to answer questions about the proposed schedule of sanitary sewer service charges. After the public hearing is closed, the Commissioners of Metropolitan will hold a meeting to consider taking final action to adopt and implement the proposed sanitary sewer service charges pursuant to Section 6-11-1230 of the Code of Laws for South Carolina. If such action is taken, these charges will be imposed on a monthly basis based on water usage and will be included on the monthly bills issued by Greenville Water to such customers receiving water service from Greenville Water and sanitary sewer collection service from Metropolitan. The Commissioners will also consider taking such further action as may be necessary to cease the imposition of the annual tax millage and sewer service fees that are currently collected on behalf of Metropolitan by the Greenville County Tax Collector. All current and potential customers of Metropolitan, including members of the general public, will be given an opportunity to be heard at the public hearing. A map of Metropolitan's service area and a copy of the schedule of sanitary sewer service charges to be implemented will be available for review during normal business hours (8:00 a.m. through 5:00 p.m. Monday through Thursday and 8:00 a.m. through 12:00 p.m. on Friday) at the administrative offices of Metropolitan located at 120 Augusta Arbor Way Greenville, South Carolina 29605. The rate study on which the sanitary sewer service charges are based will also be available for review on February 21, 2019..
